

Privacy Policy for XIMOHealth.COM

XIMO Health™ will not trade, sell, or disclose to any third party any form of customer identifiable information without the consent of the customer (except as required by subpoena, search warrant or other legal process or in the case where failure to disclose information will lead to imminent harm to the customer or others). This includes information derived from registration, subscription, and use of the XIMO Health website, products, or services.

Collection / Use of Information

XIMO Health will collect and use customer identifiable information for billing, provisioning of service, to solve problems associated with service, and to inform customers of new products or services that will better meet their needs. XIMO Health will use customer identifiable information to market products and services to the customer, but will not disclose or make available any customer identifiable information to any third parties seeking to market products. If a customer chooses not to participate in direct marketing of new products and services from XIMO Health, that customer's information will not be used for the purpose of marketing new products.

Automatic Information: XIMO Health receives and stores certain types of information whenever you interact with Ximohealth.com. For example, this website uses "cookies" and obtains certain types of information when your Web browser accesses Ximohealth.com. Cookies are alphanumeric identifiers that are transferred to your computer's hard drive through your Web browser to enable our systems to recognize your browser and to streamline the downloading process.

Examples of the information collected and analyzed include the Internet protocol (IP) address used to connect your computer to the Internet; login; e-mail address; password; computer and connection information such as browser type and version, operating system, and platform; purchase history; the full Uniform Resource Locators (URL) clickstream to, through, and from our Web site, including date and time; cookie number; and searches you have performed.

E-mail Communications: XIMO Health maintains the right to send email to visitors of our site. XIMO Health only sends email to those visitors who voluntarily give us their email address. XIMO Health does not share, sell, show, or otherwise give access to any email address submitted to us. The reasons XIMO Health may send email is to give information, streamline the purchasing process, respond to queries, and respond to support requests.

XIMO Health has invested and deployed a wide variety of technology and security features to ensure the privacy of customer information on its network. In addition, XIMO Health has implemented strict operations guidelines to ensure customer privacy is safeguarded at every level of its organization. XIMO Health will continue to revise

policies and implement additional security features as new technologies becomes available.

Communications

XIMO Health will not read, listen to or disclose to any third parties private e-mail, conversations, or other communications that are transmitted using XIMO Health services except as required to ensure proper operation of services or as otherwise authorized by law.

Unlawful Activity

XIMO Health may use customer identifiable information to investigate and help prevent potentially unlawful activity or activities that threaten the integrity of service or network integrity or otherwise violate XIMO Health's policies.

Account Information

XIMO Health will do its best to honor requests from customers for account information, for example, name, address, company, or billing information. The customer is responsible for ensuring that the information on file with XIMO Health is current and accurate.

Children's Privacy Policy
